#### IMPORTANT NOTE ABOUT CHOOSING YOUR DESIGNATED FUNERAL DIRECTOR (or not)

Everyone is welcome to join the Memorial Society and receive the benefits of membership, including current information about end-of-life topics, funeral and estate planning, meetings, discussion groups, guest speakers and the newsletter. *HOWEVER,* Should you choose NOT to choose your funeral director from our list of contracted funeral homes, you would not qualify for the CMS pricing.

### What does Direct Cremation or Immediate Burial Mean?

Some funeral directors have mentioned that our members and/or their families don't understand what direct cremation or immediate burial means.

#### if you select **direct cremation**, the funeral director will:

• pick up the body at the home/hospital/hospice;

• provide a cremation permit;

• have the body cremated at the earliest possible time that is practicable for the cremator and in accordance with legal requirements;

• arrange for the crematory to dispose of the ashes or return them to the Funeral Director to return to the family or other responsible party;

• assist the family or other responsible party in composing and placing any death notice or obituary;

• assist the family in obtaining a Death Certificate. The family shall be responsible for any direct costs for this Certificate.

NOTE: There shall be no viewing by the family or others, and the remains shall be removed to the crematory by the Funeral Director without the family's presence.

#### If you select **immediate burial**, the funeral director will:

• pick up the body at the home/hospital/hospice;

• place the body in a container of the Funeral Director's choice and which is also acceptable to the cemetery;

• refrigerate the remains, but only if necessary to meet legal requirements;

• assist the family or other responsible party in composing and placing any death notice or obituary;

• assist the family in obtaining a Death Certificate(s). The family shall be responsible for any direct costs for this Certificate(s).

• cause the remains to be interred. The Funeral Director may use any burial container. There shall be no funeral procession. The family or other parties will not be present at the interment.

## Should I Prepay the Funeral Home for my Direct Cremation or Immediate Burial?

It is possible to prepay the funeral home for cremations and burials. The money is put into a trust fund and cannot be accessed until the funeral director does the cremation or burial. The prepayment could either be a NON-price-guaranteed contract or a price-guaranteed contract. The idea of a price-guaranteed contract appeals to some people for obvious reasons.

However, the Memorial Society recommends that you DO NOT prepay for several reasons:

- The funeral home could change hands or go out of business. In that case the money can be transferred to the trust fund of the new owner or a different funeral home. But the new owner or funeral home has the right to ask you for more money than you originally prepaid.
- You could move out of the area or die outside of the area. Again, you can have the money transferred to the trust fund for a funeral home in your new area, but you will most likely be asked to add more money to the fund.
- If you haven't kept your records where they can be easily accessed or you haven't spoken to your family about your wishes, they could select another funeral home and not know that you have set aside funds to pay for your cremation or burial through the Memorial Society.
- Both times we have had changes in funeral directors, this has caused great anxiety among our members who assumed that they had paid and didn't have to think about it anymore. As you can see, prepaying requires you to maintain good records and talk to your family.

State law controls this. The prepaid money is NOT the funeral home's money. It is the customer's money. It is NOT kept in the funeral home's own bank account. Consumers have a right of refund or transfer.

You have the right to a refund of 100% of what they prepaid on a NON-price-

guaranteed contract — note the "non". If what they prepaid is a guaranteed-price contract, they are due a 90% refund.

By-Laws Change

#### Article VI

**Section 1.** The officers of the Society shall serve for a term of one year. In the event of a vacancy, the Board of Directors shall elect a member of the Society to fill the vacancy until the following Annual Meeting.

**Section 2.** No officer shall serve more than six consecutive terms.

**Section 3.** The term of any Trustee shall be for three years.


Heidi and her husband, Ron, currently reside in the city of Cleveland.

America's Changing Idea of Death

In 2020, 56 percent of Americans who died were cremated, more than double the figure of 27 percent two decades earlier, according to the Cremation Association of North America (CANA). By 2040, 4 out of 5 Americans are projected to choose cremation over casket burial, according to both CANA and the National Funeral Directors Association (NFDA).

This seismic shift represents potentially severe revenue losses for the funeral industry. Costs are prohibitive: The national median price of a funeral with burial and viewing is \$7,848, according to the <u>NFDA</u>, while the median cost of direct cremation is a third of the price at \$2,550. Cremation with viewing and funeral is comparable to traditional burial, with a median cost of \$6,970.

For families scattered across multiple states, there often seems little point in investing the effort and expense to bury a loved one in a cemetery no one will visit. Like pet food and leisure footwear, cremation is now available through direct-to-consumer websites such as <u>Solace</u> and <u>Tulip</u>.

It's leading innovators to create a growing number of green alternatives and other choices that depart from traditional casket funerals. *cont. on pg.* 7


The FCA is headquartered in Burlington, Vermont, and oversees chapters in 32 states.

We in Cleveland are but one of such groups in 32 states. We all work under the FCA (Funeral Consumers Alliance), whose statement reads as follows:

"The goal of Funeral Consumers Alliance is to ensure consumers are fully prepared and protected when planning a funeral for themselves or for a loved one. We do this by offering objective facts about funeral planning so families can plan a meaningful goodbye that fits their needs and their budget."

While the focus for both organizations is on funeral planning, the growing trend is to expand beyond the basics of costs and delve more openly and knowledgeably about the many topics on aging and dying. We at CMS try to bring some of the more pertinent topics to you, with this newsletter, on our FaceBook page and via our website (www.clevememorialsociety.org), our annual meeting in the fall,

Many new ideas pick up on people's willingness to eschew a casket, but are considered more environmentally viable than cremation. One of these options includes Recompose, the first fullservice human-composting funeral home in the United States, that is now operational. After nearly a decade of planning, research, and fundraising...Recompose is finally converting people into soil.

Other possibilities include green burials (where the body is interred in a shroud or a biodegradable container so it naturally decomposes in the ground), natural organic reduction (human composting), promession (freeze-drying the body), infinity burial suits (a mushroom suit accelerating decomposition), and alkaline hydrolysis (a water-based, energy-efficient cremation process).

"If there's anything that is going to slow down or reverse the cremation rate in the United States, it is green burials," says Kemmis, the CANA executive director. "People are looking to the greenest final disposition so that our deaths will reflect our lives."
